were looked at, where the threshold has been raised to \$130,000, the second \$130,000 being taxed at 25% and any remainder seeing taxes of 35%.

"We are doing three things. The first is taking the threshold up to \$130,000. So we are taking up the threshold and bringing down the two rates – the first from 28% to 25% and the second from 40% to 35% applicable on anything above the second \$130,000," Singh told Stabroek News in a request for clarification.

He explained that during the budget speech he could not go into full details with examples.

It was also explained to this newspaper by a source that breaking the regime down was simple. "For example, we are not looking at NIS or any other deduction you may have. So if you are bringing in an income of \$300,000, the first \$130,000 of that sum would be tax free and you are then left with \$170,000 to be taxed. Of that \$170,000, the second \$130,000 will see 25% taxes being deducted or \$32,500. The remainder which is \$40,000, will then incur a Pay as you Earn (PAYE) regime of \$35% and that means \$14.000. So you would pay in total income tax on that monthly salary \$46,500 your take home would be \$253,500. But remember that we did not take [into consideration] NIS or any other insurance or deductions your company may have," the source explained.

"Similarly, if a person makes \$150,000 per month. You take out that \$130,000 and 25% taxes would be on the \$20,000, and I have to emphasise that this is just to give a math example without NIS, which is very important..." the source added.

"Mr Speaker, in 2022, the income tax threshold was increased from \$65,000 to \$75,000 monthly then to \$85,000 in 2023 and most recently to \$100,000 in 2024. I now wish to announce an increase of the threshold to \$130,000 monthly, with effect from the year of income 2025. This represents a doubling of the threshold from the time we entered office. This will result in an additional \$8.5 billion in disposable income for workers and the removal of 22,000 persons from the tax net," he said.

"...Mr. Speaker, finally, in the interest of increasing disposable income in the hands of workers, I wish to announce a reduction in the Personal Income Tax rate from 28 percent to 25 percent for employed and self-employed workers. This measure will increase the disposable income of more than 100,000 of taxpayers and is estimated to put \$3.6 billion back into the hands of these taxpayers," he added.

Overall, he said, Budget 2025's measures, "will aggregate to over \$90 billion, not including the impact of the electricity tariff adjustment and the removal of the excise tax on fuel, being placed in the hands of individuals and businesses to promote the growth and expansion of economic activity and job creation."

Meanwhile, adjustments were also made to taxes paid on overtime where up to the first \$50,000 of those earnings would be tax-free. "This measure is designed to ensure workers are rewarded for their productivity and effort. The estimated annual cost of this intervention is over \$600 million," Singh said.
